### **UNFINISHED BUSINESS**

1) <u>Children at Convention</u> – This item has been discussed for 2 conventions. President Lewis summarized the discussions for those who are new. No proposals have been received by the board. This issue will not be put on the agenda again.

### **NEW BUSINESS**

- 1) 2017 Convention Convention Chairperson Chip Hanuscik reported that Bridgeport has agreed to host the 2017 convention instead of the 2018 convention. The hotel is the Trumbull Marriott. Extra nights will be \$99 per night (~\$116 with taxes). Chip will be meeting with Bridgeport. Prices will be comparable to this year. Chip was thanked for his negotiating skills.
- 2) Convention Dos and Don'ts President Lewis reminded the clubs that with dinners we have a cash bar. We will not open a hospitality room until after the cash bar has closed. We are not to bring our own alcohol into the room where the dinner/dance is being held. Please remind your members. Also, do not bring alcohol into the lobby. If we are caught in the room where the cash bar is we will get into trouble. We may have to pay a fine.
- 3) <u>Memorials</u> Please give the name(s) of any deceased member(s) to the Secretary. The only name submitted is Emma Breidigam from Hershey.
- 4) <u>2017 All Star Game</u> Gary Bacher from Lehigh Valley reported that the 2017 All Star Game will be held in Lehigh Valley January 29 (skills) and 30 (All Star Game), 2017. There are two hotels downtown and many more within 5 miles of the arena.
- 5) <u>2017 Elections</u> 2017 is an election year. The forms are on the website. At tomorrow's meeting there will be a presentation on how to get around the website. Nomination forms are due to the Secretary by April 30, 2017. Two members of the nominees club must sign the form. The descriptions of the offices is in the By Laws which can be found on the website.
- 6) <u>Lowell Request</u> This was sent 2-3 weeks ago. The board has not had a chance to review and discuss it. Kevin Doyle (President of Lowell Booster Club) talked about an idea of creating a grant (AHLBCC Jeremy Hall Leadership Grant) for booster club leaders or valued strong volunteers to apply for a grant to attend convention for first time attendees only or those who have not attended convention for 5 years. If this would happen it would constitute a By Law change.
- 7) <u>Hospitality Room</u> Tom Mara requested Bridgeport to host the hospitality rooms next year. He suggested closing Thursday at 12:30. Anyone hosting the hospitality room has permission to cut off anyone who is intoxicated. It was suggested to add \$6 per person for the hospitality room next year instead of the \$5. There was a question if we are purchasing too much liquor. The hospitality room is a gathering place and not a bar. Those who are helping with the hospitality room are doing a great job.

1) President Lewis reminded everyone that Saturday evening is a dress up evening – no jeans, tee shirts, jerseys.
