NEW BUSINESS

- 1) 2018 Convention Convention Chairperson Chip Hanuscik reported that Chicago has agreed to host the 2018 convention. He went and met with the hotel the Hilton Resort in Oak Brook, Illinois. He also met with Chicago's officers and committee. Craig Bochat from Chicago will reveal the theme tomorrow when he has his presentation. The location is between the 2 airports for those who will fly in. He thanked Chicago for being here and their willingness to host next year. He thanked Bridgeport for their hospitality.
- 2) <u>Future Conventions</u> Some of the smaller clubs that are not active may opt out of hosting and other clubs will move up in rotation. Manchester has agreed to host the 2019 convention. Next would be Syracuse. Responsibilities to host a convention DJ for Friday night dinner, centerpieces for both nights, any gift bags if you wish for registration, registration table. Everything else, especially the hotel, is Convention Chairperson's responsibility. The club will run the hospitality room through Chip. If any club has questions about hosting a convention, talk to Chip. It generally costs \$3,000-\$4,000 for a club to host convention. The side trips and speaker are the club's responsibility. Payment for side trips is through the club and not the Convention Treasurer.
- 3) <u>Congratulations</u> Congratulations to Grand Rapids on winning the Calder Cup and the Pittsburgh Penguins for winning the Stanley Cup.
- 4) <u>Elections</u> There is no slate. Nominations were to be received by April 30. No nomination forms were received. The existing Board was asked if they are willing to serve for another 2 years. The present officers are willing to stay on for 2 more years. Tomorrow it can be reported that the recommendation from this Executive Board meeting is to retain the existing Board. Tom Marra (Hershey) made a motion to nominate the existing Board for the upcoming elections; seconded by Rose Ann Foy (Wilkes Barre-Scranton); the motion passed.
