NEW BUSINESS

- <u>AV Equipment</u> The past few years the meetings have been getting expensive. This year would have been ~\$2,700. Last year it was ~\$1,400. The Executive Board was approached to spend \$781 and purchase our own equipment. It was decided that it would be better financially. The Executive Board approved the spending of the money to purchase the equipment. Chip has volunteered to take care of the equipment. It will always be in the hands of an officer.
- 2) <u>Elections</u> Next year is an election year. If anyone is interested in running the descriptions of the offices are in the By-laws (which is on our Website). The nomination form (which is also on the Website) must be in to the Secretary by April 30. Your nomination form needs to be signed by 2 members in good standing. If there are no nomination forms turned in, the executive board will fill in these offices.
- 3) <u>Next Year's Convention</u> Convention Chair Chip Hanuscik has heard that people are taking alcohol in open containers into the lobby. This has to stop. The hotel can close our hospitality rooms down. Manchester will host next year's convention. We will be at the Doubletree in Nashua, New Hampshire. Prices will be similar to this year (double will be ~\$250). Early room rates will be \$105 per night plus 9% tax. Noelle Clark from Manchester said they are excited to host. There is a survey for side trips. Their theme is Rockin in the Granite State.

2020 Convention – Syracuse is willing to host.

4) <u>Amendment to By-Laws</u> – Chip Hanuscik presented an amendment to the By-Laws. It was discussed at last night's Executive Board meeting. It was passed to bring it to today's meeting. There were discussions. The children enjoy the dancing. They are the future of our convention. Children should be allowed to go to the dance. We talk about bringing in new membership. When are we going to learn to accept the young people. We should not segregate certain members of our family. The children should be allowed to dance. The parents should take control of their children. If the children get hurt who is responsible. We need rules for those under 18 in the hospitality rooms. Perhaps we should consider a waiver for children under 18. This issue has been discussed ~5 years and no one put it into writing. We need to take care of liabilities. Chip said he tried to address all issues. Nancy Haryasz (Springfield) made a motion to amend the amendment to strike the dancing part; seconded by Lori Uilecan (Bridgeport); the motion passed. The amendment was amended as follows:

Children Attending Convention: Children are welcome to attend convention. Children under the age of 18 may stay in their parents' room for no additional room cost. If the parents wish to have their children attend and eat at all convention meals (Friday Dinner, Saturday Breakfast, Saturday Dinner, Sunday Breakfast) there will be additional costs. The only options are all meals or no meals. Meal costs will be as follows: Children 3 and under, no charge for meals. Children age 4 to 12 will pay 1/2 the food cost of adult meals keeping in mind that all meal costs include state tax and hotel gratuity. Special food requests for children can be made but are not guaranteed. Children age 13 to 18 will pay the full cost of food for the event. While we want children to have a good time, our convention is more of an adult event. Children will be allowed to attend the Friday Evening Dinner with no restrictions. Because alcohol is present in hospitality rooms. No one under the legal drinking age of the state or province hosting convention will be permitted without a parent or guardian (approved in writing) being present. Children under 12 will be allowed in hospitality rooms until 9 PM. Children 12 to 18 will be allowed in hospitality rooms until 11 PM. At anytime during the convention if a minor is creating a distraction or interfering with hotel or convention staff, the parents will be asked to remove the minor from the room. Parents are responsible for the conduct of their children at all times and out of respect to fellow convention attendees, convention guests, guest speakers and hotel staff, see that the rules are followed.

There was a vote on the amendment: 24 yes and 1 no. The amendment passed and will become effective immediately.

Dennis Gottesman (Hershey) will present last year's DVD following adjournment.

Jeanne Carras (Albany) made a motion to adjourn the meeting; Marey Bailly (Albany) seconded the motion; the motion passed. President Lewis adjourned the meeting at 11:36 a.m.
